RESIDENTIAL FEES

Residential inspection prices are for dwellings 0 to 2500 square feet. Dwellings over 2500 square feet will be charged an additional ten dollars per 100 square feet, which will be added to the total basic inspection fee.

Additional inspection fees may be assessed at not less than \$55.00 per visit as required due to the complexity, number of visits, or execution of the work being done.

Small-scale projects will be priced depending on the complexity of the project, the length of the project, and the number of inspections required. Inspection fees may be assessed at not less than \$55.00 per visit as required.

Plan Review Fee \$55.00

Building Code Administrative Fee \$25.00

COMMERCIAL FEES

Includes residential other than one and two family.

The commercial plan review and inspection fees shall utilize B.O.C.A. values for building cost and modifiers for construction type to determine estimated construction values (CV) used in calculating the following fees.

A. Plan review (Building)

CV to \$1.25 million	=	C.V. X .0015 (\$150.00 min)
CV \$1.25 to \$5 million	=	\$1875 + .0005 (C.V. - \$5 million)
CV over \$5 million	=	\$3750 + .0004 (C.V. - \$5 million)

B. Plan review (mechanical, plumbing, electrical, and fire protection)

C. Building Inspection fees

CV Construction Value Fee + Modifier X (C.V.) multiplier + project length X cost factor

D. Electrical Inspection fees

Electrical costs up to \$9,999	=	0.35 X elec cost
Electrical cost \$10,000 to \$74,999	=	\$350 + (cost-\$10,000 X 0.02) = fee
Electrical cost \$75,000 to \$149,999	=	\$2,150 + (cost-\$100,000 X 0.015) = fee
Electrical cost \$150,000 to \$199,999	=	\$2,900 + (cost-\$150,000 X 0.0115) = fee
Electrical cost \$200,000 up	=	\$3,500 + (cost-\$200,000 X 0.001) = fee

Commercial Building Code Administrative Fee 10% of building permit fee charge

Appeal to the Bldg. Code Board of Appeals \$200.00

Reimbursement by or the imposition upon Applicants of fees charged by the Borough's Professional Consultants under or for projects which are subject to the Subdivision and Land Development Ordinance, including but not limited to review fees and inspection fees, in accordance with the Fee Schedules attached to this Resolution and made a part hereof.

This Resolution shall take effect and be in force immediately after it is approved.
