The oral review was conducted on Wednesday, April 25, 2018 at 11:00 a.m., by Chief Bernard Dugan, Annville Township PD, chair; Lt. Robert Eachus, East Lampeter Township PD; and Sgt. Billy Wilson, West Lampeter Township PD. The review produced a passing result for the single candidate, Strasburg Borough PD officer Nick Ferretti, being presented this evening. On motion by Lee Potts, second by J. R. Johnson, the commissioners unanimously approved creation of a promotional list to be forwarded to Strasburg Borough Council, valid for one year, with Officer Ferretti as the single candidate recommended for promotion to sergeant.

There was no other unfinished business to come before the Commission.

In new business, the members received up-to-date copies of the Strasburg Borough Civil Service Commission Rules & Regulations for review at their leisure, with the direction that any questions about duties and responsibilities of a commissioner be brought to Chief Echternach for clarification.
